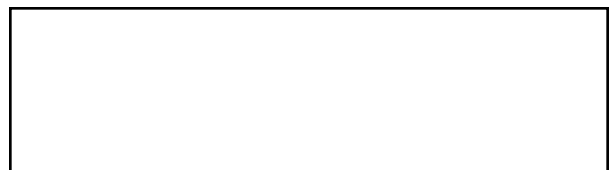

Instructions for filing a Write-in Candidate's Certificate of Announcement

Any eligible person who seeks to be elected by write-in votes to an office shall file a write-in candidate's certificate of announcement, under oath, with the proper filing officer and within the required time. (WV Code §3-6-4a)

- (1) Date of the election in which the candidate is seeking office.
- (2) The name of the office sought and the district and division, if any;
- (3) The legal name of the candidate. (First, middle and last);
- (4) The first and last name by which the candidate may be identified in seeking the office;
- (5) The county of residence and a statement that the candidate is a legally qualified voter of the county;
- (5)(a) The magisterial district of residence for candidates elected from magisterial districts or under magisterial limitations.
- (6) The specific address designating the location at which the candidate resides at the time of filing, including number and street or rural route and box number and city, state and zip code;
- (7) Mailing address, if different than residence address.

File your certificate of announcement in the correct office:

For offices on the ballot in

The Certificate of Announcement must be received by close of business on the 49th day prior to the election (Postmark is not accepted):

- The filing deadline for the **Primary** Election is March 25, 2014. (Board of Education, Conservation District Supervisor, and executive committee Only)
- The filing deadline for the **General** Election is September 16, 2014.
