To the extent the actual cost to complete the Project is greater or less than such estimates, the Board, in its reasonable discretion, may allocate and expend the available funds (including proceeds of the Bonds and other funds made available to the Board, including but not limited to School Building Authority of West Virginia grant funds and/or Faderal, State, local, lease purchase, and/or private funds) to the Project as may be necessary to carry out the intent of this Order and for additions, renovations or other capital improvements to existing school facilities in the School District, provided however, that in any event, (i) the Board shall use its best efforts to first complete the Project described above and (ii) no Bond proceeds shall be used for the purpose of providing funds for the current expenses of the Board. In the event the Board shall obtain additional money by grant or otherwise from the School Building Authority of West Virginia, the State or Federal government, or from any other source (including, without limitation, other funds available to the Board, lease purchase financing, and/or private funds) for use in the acquisition, or in addition to the proceeds of the sale of the Bonds proposed hereby, as may be determined by the Board and the granting body or agency, unless otherwise set forth in this Order.
