The Board shall be authorized to pay such trest and/or Costs of Issuance from its general funds and/or from the proceeds of the Bonds, as the Board deems appropriate at the time such interest and/or Costs of Issuance are equired to be paid.

To the extent the actual cost to complete the Project is greater or less than such estimates, the Board, in its reasonable discretion, may allocate and expend the available funds (including proceeds of the Bonds and other funds made available to the Board, including but not limited to School Building Authority of West Virginia grant funds and/or Faderal, State, local, lease purchase, and/or private funds) to the Project as may be necessary to carry out the intent of this Order and for additions, renovations or other capital improvements to existing school facilities in the School District, provided however, that in any event, (i) the Board shall use its best efforts to first complete the Project described above and (ii) no Bond proceeds shall be used for the purpose of providing funds for the current expenses of the Board. If the proceeds of the Bonds and/or other amounts allocated for the above-stated purposes are insufficient to complete the Project, then the Board, in its discretion, shall adjust escope of the Project to the extent necessary to complete the Project as proved by the voters of the School District. In the event the Board shall obtain additional money by grant or otherwise from the School Building Authority of West Virginia, the State or Federal government, or from any other source (including, without limitation, other funds available to the Board, lease purchase financing, and/or private funds) for use in the acquisition, or in addition to the proceeds of the sale of the Bonds proposed hereby, as may be determined by the Board and the granting body or agency, unless otherwise set forth in this Order.

The issuance of the Bonds may be subject to (a) the availability of other funds available to the Board (including School Building Authority of West Virginia funding or needs grants, other federal, state and/or local funding, lease purchase proceeds and/or private funding from any source or any combination thereof), in amounts sufficient, in the Board's reasonable discretion, to undertake and complete the Project, and (b) any and all other necessary actions, approvals and consents required by applicable law, provided, however, that any award of funds by the School Building Authority of West Virginia shall not be a condition precedent to the issuance of the Bonds.

If the voters of the School District approve the incurring of said debt and the issuance of said Bonds, the Board will lay annually upon the sessed valualion of all the taxable property within the School District an additional levy sufficient to provide funds for the payment of the annual erest upon tipe Bonds as such interest accuracy semiannually and the principal of the Bonds at maturity, for purposes a levy upon each \$100 luation, based upon the last assessment of such property for State and County purposes, will be required as follows:
